*This is to advise all parents / guardians, that the insurance cover offered by the AFL Brisbane Juniors is only available to players who are registered and fully paid members of Moggill J.A.F.C. To ensure your child is covered and eligible to participate, please sign and return the Acknowledgement Form to us by no later than the first day of training.*

Dear Parent / Guardian,

One of the mandatory requirements imposed on the Moggill Junior Australian Football Club (Moggill J.A.F.C.) is to protect itself and its players, by obtaining the correct Liability Insurance. This Notice is designed to give you an understanding of the cover for season 2014.

The AFL, in conjunction with the insurance broker, Jardine Lloyd Thompson Australia (JLTA), has developed a national insurance program, titled Australian Football National Risk Protection Program. The program includes personal accident, public and products liability, professional indemnity and association liability to protect every player, team, club, league and association in Australia, including the game's officials, trainers, umpires and volunteers. This policy renews annually on January 1. JLTA have, however, agreed to endorse this policy to allow clubs who have annual sign on days, which includes Moggill, to be covered from sign-on day to sign-on day.

This policy was previously paid by the AFL Brisbane Juniors (AFLBJ) on behalf of the clubs, prior to them receiving the player registration fees, on the premise that clubs had a signed registration form for each player. Unfortunately, due to excessive litigation payouts and new terms and conditions applied to Liability Insurance, the AFLBJ has again decided they are not in a position to pay the premium, until they have received the player registration fees owed from the clubs. To ensure Moggill J.A.F.C. and its players are covered, we must pay our registration fees to the AFLBJ within two weeks of receiving the signed registration form.

To protect your child, we are requesting you to please pay your registration fees by PayPal, Cheque, Credit Card or Direct Deposit, by no later than one week after signing the registration forms.

Moggill J.A.F.C. has approval from the AFLBJ to allow players who are not fully paid members to attend and participate in training sessions, (they are not permitted to participate in game day). We must stress that both organisations cannot accept any responsibility for accidents or incidents that may arise during this time. Any non-financial child who trains will not be covered by the AFL Insurance Policy, and therefore will be training at your own risk. **The Insurance Notice Acknowledgement Form below requires you to sign and return the form to the club by the first training day. By signing this form you are acknowledging you have read and fully understand the content of this Notice and the potential ramifications if these conditions are not met.**

Once registration fees are paid, your child is covered for all matches sanctioned by AFLBJ and all Official Club Training Sessions and Activities, whether at the Club's venue and any other venue nominated by the Club.

Additionally the AFLBJ does recognise that the tough economic times have some families finding it a little more difficult than normal to pay registration fees within our required timeframe. The AFLBJ have indicated that they may consider applications, (on a case-by-case basis), which would allow a family to enter into a payment arrangement. If you require an application to be lodged on your behalf, please contact us, so we can register our support to your application and send this in to the AFLBJ on our Club letterhead. ANY COMMUNICATIONS REGARDING THIS APPLICATION WILL BE KEPT DONE IN THE STRICTEST OF CONFIDENCE.
